## **Parent /Guardian Agreement**

I/We understand my signature on the front side of this registration indicates I have read and I/We are in agreement with following statements

I/We Parents(Guardians) of the named child do hereby give consent to his/her participation in any and all of the activities during our current Tampa Cricket League (addressed as TCL below ) Youth season

I/We do assume all the risks and hazards incidental to the conduct of the activities, and transportation to and from activities

I/We likewise release from responsibility any person transporting my /our son/daughter to or from activities

I/We do further release, absolve, indemnify and hold harmless the TCL , Organisers, sponsors, supervisors appointed by TCL

It has been explained to me and I/we Cricket is a serious sport and injuries from participation in this activity can be serious

I/We hereby consent to any and all medical treatment which may be deemed necessary by the attending qualified physicians if any brought by TCL .

It is my intent to grant authority to administer and perform all examinations, perform treatment and diagnostic procedures , which may be deemed advisable and necessary during the course of my child's care

In case of Injury during Practice or game, the boy/girl will receive first aid attention. The sponsor or coach will not be held responsible for any medical attention, which might be required.

TCL assumes no liability for what happens when it comes to events of Cricket due to any unforeseen accident, the parents/family may have waived their legal rights.

A limited athletic benefit insurance policy will be provided to all the participants.

Such insurance is intended to supplement your present homeowners and/or hospitalization insurance.

I/ We understand the fees given is non refundable and will be paid before my/our son/daughter starts his/her participation in the event/practice.

It has been explained to me and I understand that if my child gets injured at school or practice/game , a medical release must be provided before he/she resumes participation in TCL organized program/event/practice.

I/We understand participant or his guardian/parent initiating or participating in verbal or Physical altercation, is subject to remove from all TCL participation.

I /We understand we require to provide date of birth certificate for any verification purposes if required.

I /We declare, the information provided about the child is truthful and proof of request will be provided for any verification .

My child will abide by the rules and regulations specified by Tampa Cricket League.
